**DOCUMENTARY REQUIREMENTS FOR INVESTOR'S VISA:**

The following documents in support of these statements are submitted:

1. Photocopy of passport with the latest arrival visa and updated visa;
2. Certificate of inward remittance from the Manager of the applicant's agent bank in the Philippines indicating that the foreign currency was converted to peso currency, rate of exchange and the date it was converted (should the applicant decide to seek assistance from the Bangko Sentral ng Pilipinas for the repatriation of his investment), otherwise; conversion to peso currency is not required;
3. Written and sworn declaration that the investment shall be within the zone; (NOTARIZED)
4. Certification of allocation issued by the President/Chairman of the SBF enterprise that it has allocated US\$250,000.00 or its equivalent in other foreign currency to a foreign national assigned to render service to the said investor within the zone; (NOTARIZED)
5. Alien Employment Permit (AEP) issued by the Department of Labor and Employment;
6. Copy of SBF Certificate of Registration and Certificate of Tax Exemption;
7. Results of Medical and Psychological Examinations or Medical Certification;
8. Personal Appearance/briefing;
9. Visa Processing fee of \$50.00.
